ARTICLES OF INCORPORATION

- 1. That they constitute at least two-thirds of the Incorporators of BALLENA BAY TOWNHOUSE ASSOCIATION NO. 1, a California corporation.
- 2. That they hereby adopt the following amendment of the Articles of incorporation of said corporation:

Article SEVENTH is amended to read as follows: "SEVENTH: This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and it is organized solely for non-profit purposes. The corporation shall not distribute any gains, profits or dividends to any of its members as such, except upon dissolution or winding up,"

3. That said corporation has admitted no members other than the incorporators.



FIRST: The name of this corporation shall be BALLENA BAY TOWNHOUSE ASSOCIATION NO. 1.

<u>SECOND</u>: The purposes for which this corporation is formed are:

- (a) The specific and primary purposes are to provide for the management, maintenance, protection, preservation and development of the BALLENA BAY TOWNHOUSE DEVELOPMENT and to promote the health, safety and welfare of its members.
- (b) The general purposes and powers are to have and exercise any and all powers, rights and privileges which a corporation organized under the general non-profit corporation law of the State of California by law may now or hereafter have or exercise; provided, however, that this corporation shall not engage in any activities which are not in furtherance of the purposes set forth in subparagraph (a) above.

THIRD: This corporation is organized pursuant to the general non-profit corporation law of the State of California.

<u>FOURTH</u>: The county in this State where the principal office for the transaction of the business of this corporation is located is Alameda County.

SIXTH: The authorized number and qualification of members of the corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to due's and assessments and the method of collection thereof, shall be as set forth in the By-Laws.

SEVENTH: This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and it is organized solely for non-profit purposes. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code. If this corporation holds any assets on trust, such assets shall be disposed of in such manner as may be directed by decree of superior court of the county in which this corporation's principal office is located, upon petition therefor by the Attorney General or by any person concerned in the liquidation.
