### Architectural and Landside Message

After meeting with four new contractors, the Board has selected Wood Horse Construction to begin work on the 400 Tideway block. Wood Horse is a small company (compared to Dreager and some of the other ECHO member contractors), but Darrell Rupp and his crew have come highly recommended from other homeowner associations and other personal references well-respected in the building community. The work is to be done on a "Time and Materials" basis and we expect them to begin work late this week, with project duration of about 12 weeks. The logistics of getting building materials, tools and equipment on site is a bit tricky and we will need to marshal assistance (brains & muscle), support (work floats & boats) and access (docks & houses) to minimize the time and effort needed to get stuff to the job site. We will prioritize the work to be done in a way that addresses the most needed work first while assuring it is done in an efficient and cost effective manner.

Rich Noble will provide over site supervision for the project, and I have offered my continued services, if needed.

I appreciate being allowed to serve on the Board these last two years, and look forward to the continued success of our community.
