Two "5 MPH NO WAKE" signs have arrived and will replace the existing ones on the Ballena Blvd bridge.

The Waterside Committee had their first work party using the new dredging pump on the wave maze. I am happy to report that it has done what we hoped it would do, and that is, it helped raise the perimeter clusters of tires that were worked on. There are a lot more tires to be washed and scraped of mud and marine growth.

We will still need the divers to clean the bottom of the tires and raise the sunken clusters of the interior of the maze. The new pump will supplement the divers and offset some of the maintenance cost.

I am looking for volunteers for work parties, weather permitting, for the January 21, 22, 28 and 29th. The work day usually lasts 3 to 4 hours. We can use all the help we can get.

There are a few dock issues that are ongoing and will need attention. Ramp wheels are replaced as needed and wheel plates relocated as required. We also have a dock that will need new splice plates installed to prevent excessive flexing at a construction joint.

If you see anything regarding the waterside that needs some attention, please call me or email. Please continue to inspect your and your neighbors dock lines.

Christmas in Denmark

I have never spent a Christmas holiday outside the U.S. but have often wondered what it would be like. Our neighbor Aase Roger, a native of Denmark, spent this holiday season visiting her relatives there. She shares some of the highlights of a Danish Christmas. It begins with the advent calendar, a centerpiece with four candles, each lit starting with the fourth Sunday before Christmas Day. Next, the interior of the house is decorated in elf motif -- small, charming little sculptures sitting on shelves, knitting in corners, and generally helping out Santa. A small wreath is placed on the door to each room in the house. Things start to get serious on December 22nd, which is when Danes bring home their Christmas trees. Little cloth cones are filled with candies and hung on the tree. Real candles are attached to the branches and are lit. (A water bucket and spray bottle are handy in case of fire.) Everyone munches on the cookies, such as "brown cookies" made crisp with ammonia carbonate. "Klejner" cookies are made, rolling the dough in a rectangular shape, slitting the middle, then taking one corner and sliding it through the slit. These are then cooked in palm oil. Marzipan covered in chocolate is also a traditional Christmas treat.

On the 24th a Christmas Eve dinner is served, consisting of duckling stuffed with prunes and apples. Red cabbage and potatoes round out this course, the potatoes covered in a gravy, which Aase simply describes as "unforgettable." For dessert – a rice pudding-type concoction into which is folded whipped cream, almonds and vanilla, all this topped with a cherry sauce. This is an interesting dish as; somewhere in the middle is one whole almond. The one who eats the almond stays mum. Aase said this year her niece made a huge bowl and they had to eat it all before the almond-eater fessed-up. She said many long pauses were needed to finish this course. After cleanup the candles are lit, Christmas songs and hymns are sung while the family holds hands and circles the tree. Then the gifts are opened to the great delight of the children.

Christmas Day there is another big feast starting at 1:00. Herring, smoked eel and smoked salmon comprise the first course, followed by pastry shells filled with a mixture of chicken, asparagus and mushrooms. Next comes liver pate, fried meatballs, ham, and pork tenderloin topped with sautéed onion. Then there is a cheese course followed by the final course, a delicious fruit salad.

December 26th? People rest, and I am not surprised. They may be invited to the neighbor's for some tasty leftovers. If Danes decide to go out for a walk in the 31-degree cold, they may duck into a little café and order some glogg (pronounced "gloog") to warm up. Glogg is a wonderful

combination of red wine, port and aquavit (a vodka-like spirit) filled with raisins and seasoned with cinnamon sticks, cloves and other spices.

Strangely, I'm hungry. I had always thought Christmas in London, a sort of Dickensian, snow-flurry holiday, would be ideal. But the above menu beats bangers and mash hands down. My stomach says, let's do Denmark.
