Hopefully you have received a ballot, several reminder emails and information about the upcoming voting on revised CC&Rs for the association. This is an important vote for many reasons, one of which is our governing documents are out of date and not in conformance with prevailing statute in many cases. There is an **informational meeting on February 21** where our attorney, members of the Board, members of the CC&R committee and Massingham will all be on hand to answer questions. I want to encourage you to attend if you still have any concerns or need something clarified. It is an important vote and every vote counts.

#### Waterside Committee by Rob Larsen

Your waterside committee has been busy with changing out a few old ramp wheels with new ones. This will be ongoing until all 42 ramps will wear the new red wheels. A metal curb was installed for the access ramp at 465 Cola Ballena. This curb will stop the ramp wheels from working their way off of the protective plates and resting directly on the Brock surface.

Two "5 MPH NO WAKE" signs have been installed at the Ballena Blvd bridge.

Two divers have been dispatched to the wave maze for the general maintenance. They will be cleaning and scraping the tires to help them float higher in the water. Once they have refloated the sunken portions of both sections of the maze, the volunteers will be notified for pump and scraping duty on the perimeter tires.

Our next task will be fabricating and installing new splice plates to prevent excessive flexing at a construction joint on a Brock dock.

As always if you see anything regarding the waterside that needs some attention, please call or email.
