We are progressing with CLE, a marine consultant, in replacing the current wave maze. Our goal is to have a new wave maze designed, built and installed by fall of 2018. The schedule is very aggressive and requires many steps to meet this goal. We will continue to update the community on our progress.

The diver was out twice in October and once this month to clean and replace tires to the existing wave maze. We are trying to keep our current wave maze afloat until a new one is installed. With the upcoming storms this winter it is imperative that our wave maze is in the best condition. This has been a challenge.

A Day of Remembrance in Normandy by Jennifer Flanigan

In September my husband and I celebrated our 30th wedding anniversary by taking a Viking cruise along the Seine. One day was devoted to a visit to the Normandy Beaches. My father-in-law was a lieutenant in the Army in World War II and was taken as a prisoner of war by the Germans. My father was in the Army Air Corp, later known as the Air Force, and served as well. So in addition to the anniversary, this trip was an homage to the two of them.

It was a lovely two-hour ride from the longship to Arromanches, where we briefly toured a WWII museum. One of the highlights was a 15-minute film dealing mainly with the creation of an artificial port, which was essential in order to unload war materiel – guns, cannons, artillery -- for the invasion. Concrete blocks or caissons were made by British shipbuilders, they were submerged on the English coast, then were hauled by ferries to Arromanches to be the supports for the port. Basically a long artificial floating roadway had to be created in order for ships to dock and unload the tools with which to fight the enemy. Some hard statistics: over 500,000 vehicles,



2.5 million soldiers and four million tons of war materiel went through this port – also known as Mulberry Harbour. One marvels at the vision to create this plan, then to carry it through, all the while attempting to maintain subterfuge. Truly amazing.

That afternoon we drove to the American cemetery where nearly 9,000 U.S. soldiers are buried. The grounds are meticulously kept and are quite simple with lush grass, stately trees and a stone promenade. On one side are the graves with headstones in white marble. On the other is a pond with water lilies – this overshadowed by a smooth twenty-foot tall black statue of indomitable youth. This was a gift to us by the French government to recognize the contribution of our youth. The median age of the fallen in this battle was twenty-four. At 2:30 precisely there was a speech from a young French representative which had to do with the cemetery and D-Day, at the conclusion of which he gave heartfelt thanks to the American effort. We were then asked to face the tombstones and our national anthem was played. Then a solitary bugler played Taps. At the conclusion of those pieces our cruise director asked that those of our passengers who had served in the military please come forward. We gave them a round of applause. One of the men and women gathered was a gentleman in a wheel chair we had noticed on our ship. I later learned he was in his nineties and had served in the battle. What memories must have resurfaced for this brave, brave soldier!

Before disembarking the bus, we had each been handed a long-stemmed rose. The final part of this tribute was to place them at the grave of one of the fallen. Private Francis Burrell's gravesite was the richer by one yellow rose and several of my tears.

Executive sessions of the board of directors are provided by statute so boards can address issues involving privileged information and matters of a private nature. As a result, members do not have a right to attend executive sessions. As provided for in Civil Code §1363.05(b), boards may go into executive session for the following matters:

- 1. <u>Legal Issues</u>. This preserves <u>attorney-client privilege</u>, litigation strategy and settlement strategies for current and potential litigation matters. The association's attorney does not need to be present either in person or by phone for the board to meet in executive session to discuss legal issues.
- 2. <u>Formation of Contracts</u>. Boards may consider matters relating to the <u>formation of contracts</u> with third parties.
- 3. <u>Disciplinary Hearings</u>. Boards should meet in executive session for all <u>disciplinary hearings</u>. The accused member is entitled to attend the executive session for that portion of the meeting dealing with member's hearing.
- 4. <u>Personnel Issues</u>. Personnel matters which include, but are not limited to, hiring, firing, raises, disciplinary matters and performance reviews.
- 5. <u>Payment of Assessments</u>. Board may meet with members in executive session to discuss requests by delinquent members for payment plans.
- 6. <u>Foreclosure</u>. The decision to initiate foreclosure shall be made only by the board of directors of the association and may not be delegated to an agent of the association. The board must approve the decision by a majority vote of the directors in executive session. <u>Civ. Code §1367.4(c)(2)</u>.
